

BY-LAW NUMBER 14- 34
OF
THE CORPORATION OF THE TOWNSHIP OF CLEARVIEW

A By-Law to acquire Part of Lot 9 West of Concession Line, Plan 194 Nottawasaga and Part of Park Lot 20 South of North Street, Plan 194 Nottawasaga, Township of Clearview, County of Simcoe, designated as Part 1 on Plan 51R-39388 and to establish same as part of the municipal highway system.

WHEREAS Subsection 11 (3) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a lower-tier municipality may pass by-laws with respect to highways within its jurisdiction including a by-law to establish and name a highway for public use;

AND WHEREAS the Council of The Corporation of the Township of Clearview deems it expedient to acquire Part of Lot 9 West of Concession Line, Plan 194 Nottawasaga and Part of Park Lot 20 South of North Street, Plan 194 Nottawasaga, Township of Clearview, County of Simcoe, designated as Part 1 on Plan 51R-39388, for road widening purposes;

AND WHEREAS the Council of The Corporation of the Township of Clearview deems it expedient to confirm its jurisdiction and to widen North Street over Part of Lot 9 West of Concession Line, Plan 194 Nottawasaga and Part of Park Lot 20 South of North Street, Plan 194 Nottawasaga, Township of Clearview, County of Simcoe, designated as Part 1 on Plan 51R-39388 and to establish same as part of the municipal highway system;


NOW THEREFORE the Council of The Corporation of the Township of Clearview enacts as follows:

1. THAT The Corporation of the Township of Clearview acquire Part of Lot 9 West of Concession Line, Plan 194 Nottawasaga and Part of Park Lot 20 South of North Street, Plan 194 Nottawasaga, Township of Clearview, County of Simcoe, more particularly described in Schedule "A" attached hereto and forming part of this By-law.
2. THAT North Street be widened over Part of Lot 9 West of Concession Line, Plan 194 Nottawasaga and Part of Park Lot 20 South of North Street, Plan 194 Nottawasaga, Township of Clearview, County of Simcoe, more particularly described in Schedule "A" attached hereto and forming part of this By-law and established as part of the municipal highway system.
3. THAT this by-law shall come into force and effect immediately upon the final passing thereof.

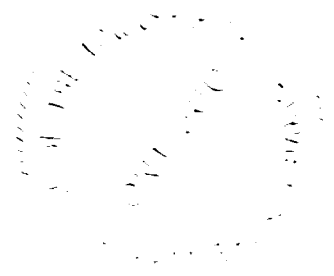
By-law Number 14-34 read a first, second, and third time and finally passed this 12th day of May, 2014.
