

**BY-LAW NUMBER 14-35
OF
THE CORPORATION OF THE TOWNSHIP OF CLEARVIEW**

A By-Law to deem a portion of Registered Plan 194, in the former Township of Nottawasaga, now in the Township of Clearview, not to be a registered plan of subdivision for purposes of Section 50(3) of the Planning Act.

WHEREAS Section 50 (4) of the Planning Act, R.S.O. 1990 Chapter P. 13 as amended authorizes a local Municipality by by-law to designate any plan of subdivision, or part thereof, that has been registered for eight years or more, to be deemed not to be a registered plan of subdivision for the purposes of subsection (3);

AND WHEREAS Plan 194, in the former Township of Nottawasaga, now in the Township of Clearview has been registered as a plan of subdivision registered in the Registry Office for the County of Simcoe (No. 51) for eight (8) years or more;

AND WHEREAS it is deemed expedient in order to control adequately the development of land in the Municipality that a by-law be passed pursuant to Section 50(4) of the Planning Act to designate a portion of Plan 194 as deemed not to be a registered plan of subdivision for the purposes of Subsection 50(3).

NOW THEREFORE the Council of The Corporation of the Township of Clearview enacts as follows:

1. THAT those portions of Registered Plan 194, in the former Township of Nottawasaga, now in the Township of Clearview, County of Simcoe being Lots 6, 7, 8 and Part of Lot 9, West of Concession Line and Part of Park Lot 20, South of North Street, Plan 194, more particularly described in Schedule "A" attached hereto and forming part of this By-law, are deemed not to be part of a registered plan of subdivision for the purposes of Section 50(3) of The Planning Act.
2. THAT this by-law shall come into full force and take effect upon registration in the Registry Office for Simcoe County (No. 51), subject to the provisions of Section 50(26), (28) and (29) of the Planning Act, R.S.O. 1990, Chapter P. 13 as amended.

By-law Number 14-35 read a first, second, and third time and finally passed this day of 12th day of May, 2014.
