




## Notice of Study Completion Municipal Class Environmental Assessment South East Stayner Sanitary Servicing, Township of Clearview

## The Study

The Township of Clearview (Township) has completed a Municipal Class Environmental Assessment (EA) to address the need for Sewage Collection to service the existing unserviced area in the south east quadrant of Stayner, including the proposed development referred to as 'Manortown Homes'. The approximate extent of the Study Area is shown on the map.

The Preferred Solution is to build a new pumping station on a new site to service the Study Area.



## **The Process**

The Study followed Schedule B of the Municipal Class Environmental Assessment process described in the Municipal Engineers Association guide (October 2000, as amended in 2007, 2011, & 2015) which is an approved process under the *Ontario Environmental Assessment Act*. The study evaluated alternative solutions with consideration for the natural, cultural, technical and economic environment, and recommend a preferred solution in consultation with the public, Indigenous communities and agencies. A Notice of Study Commencement inviting public input was first published on July 18, 2019. A virtual Public Information Centre was held from July 2 to August 4, 2020.

## **Project File Report**

A Project File Report (PRF) has been prepared to document the planning and decision-making process for this Study. By this notice, the PFR will be placed on the public record and be available for a 30-day review period starting January 21, 2021 and ending February 22, 2021 in accordance with the requirements of the MCEA process.
